## Fiscal Year 2014 Budget Request: \$7.8 Billion

The [CDC Coalition is a coalition of more than 140 organizations](#) committed to strengthening our nation's prevention programs. We represent millions of public health workers, clinicians, researchers, educators, and citizens served by CDC programs. We believe Congress should support CDC as an agency – not just the individual programs that it funds. Given the challenges and burdens of chronic disease and disability, public health emergencies, new and reemerging infectious diseases and other unmet public health needs, **we urge a funding of \$7.8 billion for CDC's programs in FY 2014.** Unfortunately, the President's FY 2014 budget request for CDC represents a nearly **\$277 million reduction when compared with FY 2012.** These proposed cuts come on top of the \$577 million reduction to CDC in FY 2013 due to the sequester and reduction in Prevention and Public Health Fund resources. After these cuts, CDC's budget authority is now lower than 2003 levels. At the same time, state and local health departments are operating on tight budgets and with a smaller workforce. Cuts to CDC's programs are not sustainable and will reduce the ability to investigate and respond to public health emergencies as well as food borne and infectious disease outbreaks.

CDC is faced with unprecedented challenges and responsibilities, ranging from emergency preparedness, chronic disease prevention, to combating the tobacco and obesity epidemics. CDC funds programs in injury control and violence prevention; health promotion in schools and workplaces; governmental and community initiatives to prevent diabetes, heart disease, stroke, cancer, lung disease and other chronic diseases; improvements in nutrition and immunization; programs to monitor and combat environmental effects on health; interventions to improve oral health; preventing infant mortality and birth defects; preventing antimicrobial resistance and infectious diseases; mental illness prevention; public health research and data collection and analysis on a host of vital statistics and other health indicators. It is notable that more than 70 percent of CDC's budget supports state and local health organizations, nonprofit organizations and academic institutions, many of which continue to struggle to meet growing needs with fewer resources.

CDC serves as the command center for our nation's public health defense system against emerging and reemerging infectious diseases. From pandemic flu preparedness to West Nile, smallpox and SARS detection, CDC is the nation's -- and the world's -- expert resource and response center, coordinating communications and action and serving as the laboratory reference center. States and communities rely on CDC for accurate information and direction in a crisis or outbreak.

In addition to ensuring a strong public health infrastructure and protecting Americans from public health threats and emergencies, CDC programs are crucial to reducing health care costs and improving the public's health. Despite the progress CDC has made to meet these needs, the agency's programs have been woefully underfunded to confront the myriad public health issues facing the nation. **We urge you to support a funding level of \$7.8 billion for CDC programs in FY 2014.**
